RETURNS OF THE RANDOLPH COUNTY FEBRUARY 2021 GRAND JURY

Bond Return for the indictments returned by the February 2021 term of the Randolph County Grand Jury will be on **March 1, 2021, at 1:30 p.m.**, at which time bond will be set and trial dates will be determined. I ask that you please make special note of the date and time of bond return to help publicize and, thus, notify the Defendants of that date.
